KMR Driving School, LLC hereinafter referred to as "The Driving School" agrees to provide applicant, hereinafter referred to as "Student", (24) hours of online & instructional (8) hours of practical driving instruction based on the Ohio Driver Training Curriculum. A student must be at least 18 years old; state of Ohio regulations requires the Driving School to make all training available by or within (6) months. Should a student be unable to attend available training sessions offered, the Driving School is relieved of the obligation. Regulations prohibit more than four hours of training to be conducted in one day. The Driving School shall furnish a Licensed Instructor licensed by the Ohio Department of Public Safety.

This fee must be paid-in-full at time of registration. A\$30 fee for any check returned due to insufficient funds.

Driving instruction will not begin until tuition and fees are paid-in-full.

No exam will be given until all class work has been completed. Students must make up the same classroom session as missed. Exams will only be given on regularly scheduled exam dates and times. Should a student fail to attain a passing score on all (3) of the different final exams, the course will need to be taken of over, at no cost to the student. If the student must cancel a scheduled driving appointment. All behind the wheel (BTW) cancellations must be made before a minimum of 24 hours prior to the scheduled appointment. Failure to do so will result in an additional fee of \$35. The same cancellation fee shall apply should the student fail to appear for, or for any reason, not be prepared to take the scheduled lesson. No further scheduling of driving will be done until this cancellation fee is paid.

Students are required to complete all training within six months of the date of this contract being signed. There may be no refunds, nor can any students transfer to another person provided at the time or any time after payment has been received. Upon expiration of this agreement, a reinstatement fee may be charged before any further services are provided. The Driving School does not guarantee the issuance of a driver's license to the student. All hours of classroom and driving instruction are good only at the Driving School and are non-transferable to any other Driving School. The Driving School reserves the right to cancel this agreement at any time, should the student's conduct indicate a lack of responsibility to safely operate a motor vehicle. Should this agreement be cancelled under such circumstances, all fees may be pro-rated, based upon the hours of service provided prior to cancellation.

Driving School shall furnish a certificate of completion to all students under the age of 18 who successfully complete the course. The Driving School <u>will not</u> be responsible for any driving exam appointment made before this certificate has been received. A <u>duplication fee of \$25</u> will apply should a student need an original certificate replaced.

KMR Driving School, LLC offers our driving school vehicle to rent at a reasonable cost to also take your driving test. KMRDS vehicles are only available for rent if ample notice has been given and RSVP (1-2) weeks in advance with full payment paid.

You need to also have the statement "Driving schools are licensed through the Ohio Department of Public Safety through the Driver Training Program at 1970 W. Broad St. Columbus, OH 43223."
